

PRINT 19 FREIGHT TARGET SCHEDULE

A target freight schedule is essential for large shows like PRINT 19. This schedule orchestrates the move-in of freight in a logical order, allowing for the maximum utilization of labor at the most favorable rates.

INBOUND TARGET SCHEDULE

This schedule refers to the time your freight carrier has been assigned to be checked in at the Freeman Marshalling Yard to be placed in line for unloading.

- Please refer to the Target Floor Plan Map for your move-in date and time.

This schedule is for the move-in of all freight including equipment display and product. You are not required to begin setting your display at this time. No trucks will be checked in for unloading after 2:30 p.m. daily. If your vehicle checks into the Marshalling Area after 2:30 p.m., your driver may be turned away and asked to return the next day. If your booth number is not shown on the floor plan, but you know where it is located, simply use the color code of the adjacent booths to determine your assigned target date and time.

MISSED TARGET/REQUEST FOR DATE CHANGE

If you miss your target date, your vehicles will not be unloaded until after all on-target vehicles have been unloaded, regardless of when your vehicle checked in at the Marshalling Area. This means you may incur a 25% additional charge for overtime unloading and cause your truck driver to wait all day for unloading.

If you cannot adhere to your assigned target date and wish to change it for any reason, please make arrangements with Freeman. **No target date will be changed without approval from Freeman.** Written requests for changes are required and will be acknowledged in writing (include booth number, dimensions and weight of heaviest piece, total number of pieces or number of trailers, name of carrier, as well as delivery time requested.)

An answer to your written request for a target date change will be emailed within 48 hours of receipt.

All exhibitors have been assigned a targeted move-in date and time and must attempt to deliver at the targeted time unless an exception has been granted. However, **if your exhibit space is 300 square feet or smaller, you will not incur off-target charges should you not meet your target date.** Also, if you ship your materials to the Freeman Warehouse, you need to ship according to the warehouse deadline and do not have to follow the target date.

DISMANTLING

Outbound freight is not targeted. See installation and dismantling schedule in Tab 2.

GENERAL INFORMATION

Please note, the "No Freight/Fire Safety Aisles" on the target floor plan. These areas must be kept clear in order to provide access to the Exhibit Halls for emergency vehicles and the orderly movement of freight.

It is your responsibility to notify your freight carrier, display builder or installation and dismantling company of your target date.

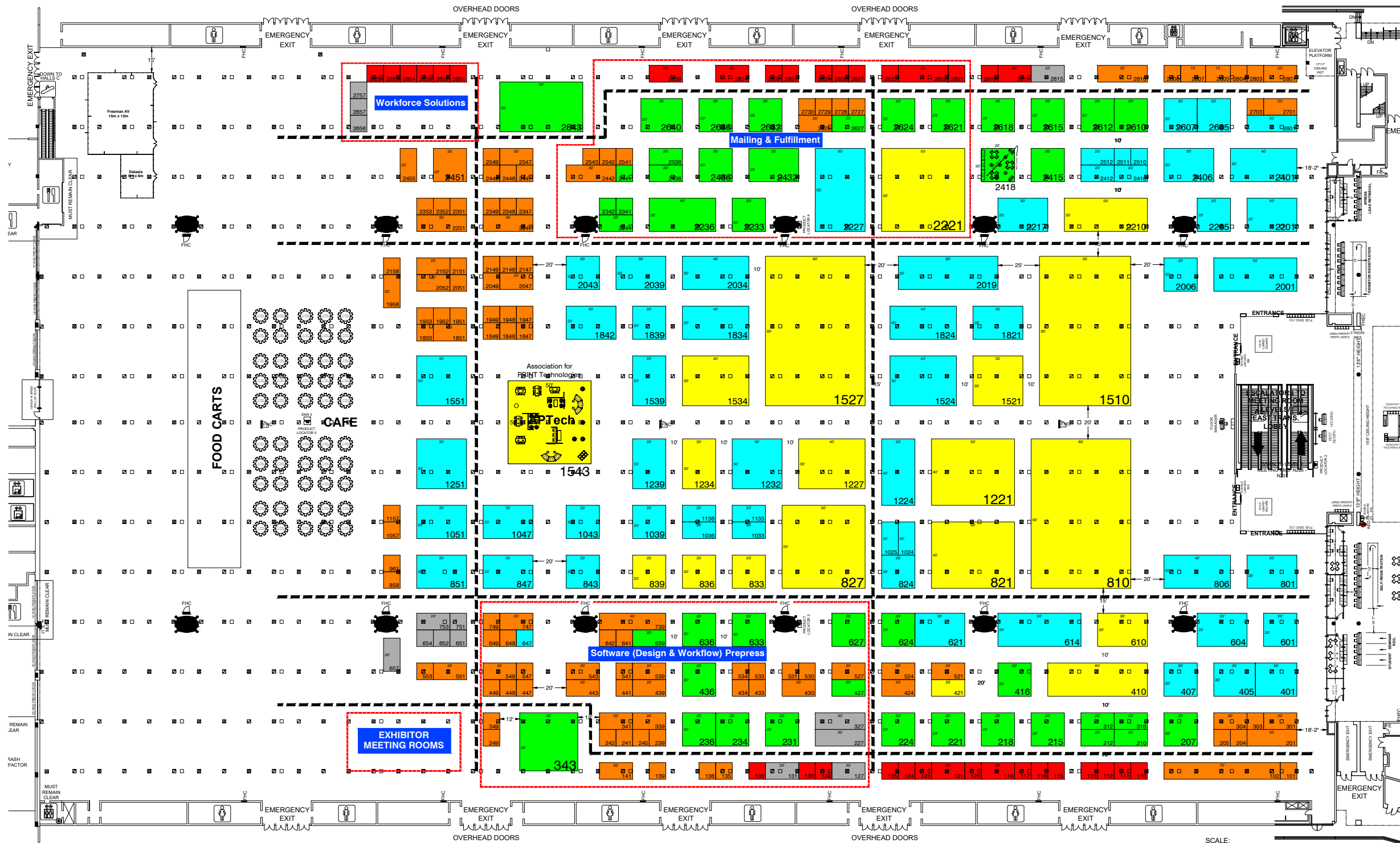
